Engagement overview & context:

In line with their No Deforestation policy commitment, many companies, including Cargill, have invested in satellite technology to help them monitor and address deforestation risk in their supply chain. This effort relies very much on the support and cooperation of upstream suppliers (palm oil mills, FFB dealers, plantations) to incorporate better transparency and traceability to help Cargill understand where their palm oil fresh fruit bunches (FFB) are coming from.

As such, Cargill, together with Earthworm Foundation (EF), have partnered with Prosper to conduct a focus group engagement workshop with all 10 Prosper-owned mills to improve the traceability and governance on fresh fruit bunches (FFB) supply base to meet Cargill's No Deforestation commitment.

This report captures findings from the workshop, as well as action plan to support Prosper to better align with industry expectations on upholding the No Deforestation commitments.

Workshop Objectives:

This workshop aims to ensure:

- Mills understand what is required to collect traceability data from their suppliers, especially FFB dealers.
- Mills are aware of how supply chain monitoring works using GPS and maps.
- Mills are aware of NDPE action plan.

The one-day workshop covered 4 topics:

- 1. Traceability to plantation;
- 2. Supply chain mapping & deforestation monitoring;
- 3. How to engage with FFB dealers;
- 4. NDPE action plan (Tools 4 Transformation -T4T)

Key findings and recommendations

Topics	Findings	Recommendations
Topic 1: Traceability to Plantation	Understanding of TTP and market requirements has increased notably after the workshop.	Cargill to maintain regular engagement on latest market development with Prosper.
Topic 2: Supply Chain Monitoring in Palm Oil Industry	Understanding of technical knowledge has increased, but there is room for improvement.	Prosper to refer to training slides and online materials attached in <i>Appendix 4</i> for self-practice and implementation.
Topic 3: How to collect TTP data from FFB dealers	Understanding of engagement approach has increased, but there is room for improvement.	Prosper to co-engage FFB dealers with Cargill and EF. See slide on Next Steps: Follow up visits.
Topic 4: NDPE Action Plan	Understanding of T4T has increased, but more training is needed on how to use the action plan.	Prosper to include mills in answering T4T questionnaire and developing action plans.








